EXECUTIVE ORDER NO. 06-2016

APPOINTMENT OF FISH WARDEN/BANTAY DAGAT IN THE MUNICIPALITY OF CALATAGAN, BATANGAS

WHEREAS, R.A. 7160, otherwise known as Local Government Code of 1991, mandates the local government unit to adopt measures to protect the coastal and marine environment within their respective jurisdiction;

WHEREAS, R.A. 8550, Philippine Fisheries Code of 1998, similarly mandates the local government units to enforce laws and regulations relative to the protection of the coastal and marine resources;

WHEREAS, the primary consideration in the successful enforcement of fisheries and environmental laws is the active participation of the municipal fisher folks community;

NOW, THEREFORE, I, PETER OLIVER M. PALACIO, Municipal Mayor of Calatagan, Batangas by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. Appointment of Fish Warden/Bantay Dagat

Section 2. Functions and Duties of Deputized Fish Warden/Bantay Dagat

As deputized Fish Warden/Bantay Dagat, the above named persons are authorized:

1. To enforce fisheries and environmental laws in the coastal areas of the Municipality of Calatagan, Batangas;
2. To do citizen arrest as provided by the rules, regulations and laws in the Rules of Court;
3. To sign activity reports relative to the performance of their functions and duties as deputized fish warden/bantay dagat;
4. To file and prosecute illegal fishers and environmental cases in the proper venue.

Section 3. Repealing Clause. All prior issuances on the appointment of Fish Warden/Bantay Dagat inconsistent herewith shall be deemed superseded by the Order.

Section 4. Effectivity. This Order shall take effect immediately.
